Sequence X Form 3 Summary of Test Method

The Chain Wear test is a fired engine dynamometer lubricant test which evaluates the ability of a test lubricant to reduce timing chain wear. The test method is a cyclic test, with a total running duration of 216 hours.

The Sequence X uses a Ford water cooled, 4 cycle, in-line cylinder, 2.0 liter EcoBoost engine as the test apparatus. The engine incorporates a dual overhead cam, four valves per cylinder (2 intake; 2 exhaust), and direct acting mechanical bucket lifter valve train design. The timing chain is replaced each test. An Eight hour break-in schedule is conducted prior to going on test conditions. The Chain is measured prior to installation, after break-in and at the end of test.
