Agenda Items:

- Approve TGC Fuel Task Force Recommendation for measuring Aromatics using ASTM D5186 mass% in place of ASTM D1319 volume% for fuel batch approvals for PC-9-HS and PC-10 fuels for the appropriate Caterpillar tests

- Alternate Fuel Supplier Request Prasad Tumati from Haltermann Solutions is interested in becoming a possible alternate supplier for PC-9-HS and PC-10 test fuels. CAT SP needs to start discussion on what engine testing would be required

Discussion:

- Discussed fuels update for D5186 outlined in agenda.
 - Jim Gutzwiller motioned to accept the measurement of aromatics using ASTM D5186 mass% in place of ASTM D1319 volume% for fuel batch approvals for PC-9-HS and PC-10 fuels for all CAT tests and that the

procedure would be updated to reference the external documents concerning fuel specifications. Sean Moyer 2nd the motion, none opposed, none waived.

- Elisa Santos presented analysis of COAT matrix data:
 - Proposed CF = .9606
 - Presented list of test changes/updates
 - Presented LTMS options and proposed -1 oil targets and standard deviation
 - Backwards compatibility with 1005-5 oil was discussed
 - Hind Abi-Akar motioned to accept the proposed CF=.9606, Jim McCord 2nd the motion, none opposed, none waived.
 - Hind Abi-Akar motioned keep the target for 833-1 oil of 11.94%, change the target for 832-1 oil to 10.23%, and apply a common standard deviation RMSE = 0.2774. Jim McCord 2^{nd} the motion, none opposed, none waived.
 - Jim Gutzwiller motioned the following:
 - The COAT LTMS will be reset using only test run on -1 oils started on or after 10/01/2018 with a CF=0.9606 applied. Calibartion periods will start on 05/13/19 with a calibration period of 6 months or 9 tests.
 - Tim Griffin 2nd the motion, none opposed, none waived.
- Group discussed what would be required to approve an alternate fuel supplier on CAT tests. More discussion will be needed to determine what will be required.
