# **COAT Procedure Update:**

- Bob Warden and Tim Griffin provided feedback on procedural updates and corrections
- An engineering meeting will be held to complete the procedure review

#### **COAT Test Stand Reference Status:**

- Lab A referenced on A-Batch filters
- Lab B reference expired (last run on A-Batch filters)
- Lab G reference expired and test stand has been relocated requiring multiple tests (last run on A-Batch filters) Getting ready to reference the stand but low filter supply (A)
- SP had agreed to bring future filter batches in with stand referencing (similar to batch hardware in other diesel tests) Can each lab move to the new filter batch after running a reference or do we need coordinated references and move at the same time? How many Batch – A filters are at the labs? Could there be a redistribution of filters between labs?

- Panel discussed the shift in reference test results on 832-1 oil
  - All three labs are showing higher aeration levels on 832-1
  - o Discussion on possible causes and solutions
    - Re-blend of 832 oil possible
    - Large volume of 832-1 oil would be disposed of if the oil is dropped
    - Would need to determine process for bring in a new stand which currently requires running three tests including 832-1 oil
  - Removing 832-1 oil from the LTMS was discussed at length with further discussion planned during the next SP meeting

## **COAT - EOAT Testing API Funding Update:**

- API agreed to fund x1 EOAT test and x2 COAT tests as part of the COAT EOAT compatibility matrix
- Would possibly still need an additional x1 EOAT and x3 COAT tests to complete the matrix
- Further discussion is needed

 Jim Gutzwiller will be retiring at the end of the month and Jacob Goodale will be taking over the role of CAT SP Chairman
