ISM Crosshead Weight Loss Correction Factor
Doyle Boese reviewed his presentation, which is attached. After some questions and discussion, Shawn Whitacre moved (Bob Campbell, second) to modify the CWL correction factor to +2.5 mg (from +1.3 mg), for all tests starting on or after April 30, 2011. Further discussion followed. The ACC proactive charts seem to confirm that an update in correction factor may be necessary, but it was difficult to quantify. Jeff Clark was asked to investigate how the ACC proactive charts are generated and the significance of the charts. Jim Moritz called the question, the motion passed 5-0-4. Without controversy, the Information Letter changing the CF can

be issued.

Doyle noted that a possible change to the IAS correction factor was not statistically significant (as was the CWL CF change).
