1) Chairman Cooper convened the group and stated the objective of the call was to clean-up the remaining issues around dealing with the correction factors, transformed units, charting and final merit calculations. TMC advised that they will be able chart the 3 parameters in transformed units and avoid changing the calculation of the final merit numbers from the changes in the numbers in the F and L report packet fields. This could be a critical issue for a merit calculated around the pass/fail line. All changes to the labs are then transparent. Action item for TMC to redo the charts in transformed units. This is not an LTMS change.

Motion (Proposed: G. Shank/Seconded: J. Moritz): The 3 charted parameters will be charted in transformed units. TMC will use test results in transformed units and express targets in transformed units.

Motion carried without objection, TEI waived.

2) Request for TMC to request Lyle Bowman to address editorial changes with T-12 merit system in D4485.**

**POST-MEETING CORRECTION - The Pass Car and Heavy Duty class panels have control over revisions to D4485. Necessary

corrections should be communicated by class panel members (TMC is not a member of class panels) to the respective class panel chair, and to Lyle Bowman (who makes the actual revisions).

- 3) Nomenclature for fuel and parts batches. Requests for standardization and simplification. Use six digit serial kit number and letter only for the critical parts. Example: 123456-STWN. Introduce new nomenclature on new kits. Boxes should state T-11 or T-12. Request for separate column (4) for each part type.
- 4) Request from TEI to swap out any old parts kits as soon as possible.
- 5) The surveillance panel will need to watch the reference data on the T-12 carefully. The previous batch of hardware seemed to change with time.

Surveillance panel to meet and review reference data on May 16th at 2:00 pm eastern time. Will include T12, T11 and T8.
