Call Purpose: Cover topics prior to NCDT Meeting this coming week. Discuss next face-to-face meeting

Information for NCDT:

Greg and Mike stated that they now have six discrimination oils of different technologies that will be shown at the NCDT meeting. The oxidation break in these oils is different in response to TMC 812-3. Exxon will be running one of these discrimination oils, previously run at another lab, for reproducibility purposes. NCDT will be collecting data at this meeting for an anticipated IN/OUT decision in November.

There is still need for Southwest to confirm stand performance following the changes made at the face to face meeting, Greg was planning on discussing this with Jim McCord at the NCDT meeting.

Build Workshop/Face-to-Face:

Lubrizol will be hosting a build-workshop for the DD13 the week of November 4th. In the later half of the week, Afton may host a T13 group meeting/stand inspection Christian Porter will confirm this once he has checked with Bob Campbell. The current plan was to be up and running the stand run on the reference oil at the time (shake-down now, going well), so a stand inspection will require a shutdown to occur for a short time. Afton and Intertek have both offered to host a build workshop

for the T13, however Afton would need a second engine for this to occur. Greg indicated that if it were to be held at Afton, he may be able to get a few additional Volvo staff involved with the workshop.
