Status of current VG fuel batch:

Haltermann currently has around 88,000 gallons of fuel remaining for sale to the VG test laboratories. This fuel together with volumes remaining at the test laboratories would last 6-9 months based on the level of VG testing over the last few years. There are some indications that the testing levels for the rest of the year may be much higher which makes the testing and approval of a new fuel batch an imperative. We should try to avoid a run on the tank.

<u>ACTION</u>: TMC/Grundza to compile a more complete assessment of VG fuel inventories and projections of the amount of VG testing in coming months. This must include any research work.

New VG fuel batch

Haltermann reported they are ready to blend 4000 gallons of a test fuel blend and will buy 2 VG tests at SwRI and IAR on the TMC test oil 1006-2. The laboratories committed to run these tests on calibrated stands once the fuel arrives in San Antonio. The results of these VG tests could be available in late October and if so will be reviewed at a VG SP call ahead of the VG SP meeting November 12th P.M. in Detroit.
