The committee discussed several of the AAM products with the K2XX second a small banjo type of axle that would require modification to each installation.

The chair will by May 18, 2012 get a vehicle part number of a production axle 8.6" light duty non limited slip axle that could be modified, reviewed for fit and function. If labs agree the functionality is acceptable the axles will be screened using reference oils and equal percentage of water based on oil fill for severity checks.

The chair will request AAM to quote a version of the 8.6" K2XX axle without tubes for the labs to purchase and begin screening tests for verification of similarity to the current axle model.

#### Greetings all,

I have attcahed a file containing the L-33 munutes. Comments and corrections are welcome. I believe that I captured the major issues for the L-33. AAM has already replied with part numbers and vehicle for the proposed axle and availibility. This axle can be produced without tubes same as we currently use. I initially requested a 4.10 ratio but it is not ready for production at this time. They did offer the 4.10 in the future if we feel that our other three options are not acceptable. They can offer now a 3.23, 3.42, and 3.73. I believe that the 3.73 would be acceptable for our use even in the future as the gears are mostly a mixing device for this test. The axle is a GMT900 series 8.6" ring diameter open differential. Part number is 20937830. I checked and it is a good number. It fits a 2WD or 4WD Silverado 1500 4.3L V6 Chevy. I don't plan to order mine until next week. I do have a 2008 version here and was able to measure the housing. It is about 17"wide by 18"long without tubes. It will fit in the ovens. In our lab we will need to modify our mounting stands with new saddles and to allign with the motor. The front flange will require a larger ujoint also. My hope is there is a combo ujoint that will fit the current shaft and new flange. I have not checked on this mod yet. Based on all I know currently this axle has a chance to be the next L-33 test part.
