- The current status of the test was presented: the hardware has been approved for use pending the information letter to update the procedure and the availability of the rating templates; a 0.6 merit correction factor will be applied to the final rust value for all candidate tests.
- The TMC cannot provide a date for when the rating templates will be available. The TMC will provide temporary rating templates to each lab until the official templates are available.
- AR to provide drawing of the thermocouple drill guide to TMC for addition in the information letter.
- All labs will be required to reference their stands before using the new hardware.
- LRI will be informed of the hardware approval and c.f. of 0.6 merits during the LRI open meeting by Xes Venhoff's ASTM Update presentation.
- The K2XX hardware is expected to be available until at least 2018. Originally the labs planned to place another order at the end of 2016 but due to delays in approving the hardware, the order is not expected to be needed until the end of 2017.
- During the hardware shortage with the Dana v01.1 axles, the reference period was doubled to 20 tests or 6 months. Keeping the extended reference period was discussed.
- A motion was made by Rebecca Warden to define the reference period for the L33-1 test to be 10 tests or 5 months, whichever comes first. The motion was seconded by Troy Muransky. The motion passed with 6 for, 0 against, and 1 abstention.
- Because of the reference period extension, instrument calibration frequency was discussed.
- A motion was made by Matt Umerley that states an instrument calibration is required prior to every reference test. The motion was seconded by Allen Comfort and passed unanimously.
- Motion was made to adjourn the meeting by Angela Trader and seconded by Matt Umerley. Motion carried unanimously.
