#### 2014 Batch Order

Frank Bowler (Dana) was unable to call-in. Gary Schmalbach (Dana) called in to provide build update. Gary stated that all material needed for the build was on track, no hold-ups exist. Dana Team continues to meet twice a week for this project, (Tuesdays & Thursdays). Build has been reduced to two batches.

Dana had asked if there were any issues with recent packaging of axle shipments, none were noted from the labs.

Lubrizol has volunteered to visit Fort Wayne for build/process inspection. Chair to coordinate appropriate timing of visit with Frank Bowler.

Labs reconfirmed that a pilot batch was not necessary; one lab would spearhead the initial referencing of this batch and inform remaining labs of any tuning changes required.

### **TMC Reference Oil**

Six reference runs were presented, (only from a single lab) and the data looks consistent using correction factors of +6% Coast Side Pinion Scoring & +4% Coast Side Ring Scoring. No correction factor adjustment is necessary at this time.

S. Parke from the TMC has added two columns to the online database to clearly indicate which tests include correction factors as well as the correction factors used for both the pinion and the ring.

### L-42-1 Design Scope

Three "must haves" were noted; (1.) New test needs to maintain severity and historical performance with TMC reference oils and commercial fluids, (2.) New test needs to use hypoid gear set, and (3.) New test needs approval of OEM's.

If a path similar to L-37-1 is chosen, convert the stand from fired engine to electric input motor first (using current Dana hardware), once this data lines up with historical results, focus could be moved to changing the hardware.

It was suggested to approach the committee as well as the OEM's for wants, needs and ideas concerning L-42-1.

The group agreed an L-42-1 Taskforce was needed. Volunteers (see below) from the group will begin holding taskforce teleconferences to better define proposals. A separate meeting will be held at the November LRI for L-42-1 Taskforce.
